**THE FOLLOWING REQUIREMENTS MUST BE COMPLIED WITH BEFORE SERVICE CONNECTION.**

1. The tap fee must be paid 2 weeks prior to the Town’s work. **Billing for service will begin immediately after installation.**
2. Once tap has been made, water service will not be installed until an application for service has been completed.
3. The applicant or the plumber must purchase a plumbing permit before work is to begin on property.
4. **FOR WATER TAP:** A ¾ ball valve and valve box are provided with water service tap fee. The owner’s responsibility begins at the female connection on the customer side of the meter box and including the ¾ valve and box.
5. **FOR WATER TAP:** The water pressure at the location of your tap is \_\_\_\_\_PSI. If the water pressure is too high, it is your responsibility to have a pressure-reducing valve installed at your expense.
6. **FOR WATER TAP:** If you are currently on a private well, before you connect to Town service, all lines from the existing well must be disconnected and in no way connected to the Town water supply system.
7. A RPZ and a fiberglass above ground box are required on all irrigation meters. A copy of the initial test results must be provided and RPZ must be tested yearly thereafter.
